MULTI-FAMILY REGISTRATION REQUIRED DOCUMENTS CHECK LIST

Texas Education Code (TEC) Section 25.002(f) requires that a child may only be enrolled in public school by the child's parent or by the child's guardian or other person with legal control of the child under a court order.

For the period during which the ineligible student is enrolled, person is liable for the maximum tuition fee the District may charge or the amount the District has budgeted per student maintenance and operating expense, whichever is greater. An offense under this section is a Class C misdemeanor.
